**Congress forms panel to study matters related to caste census**

**New Delhi:** Congress president Sonia Gandhi on Friday constituted a seven-member committee to study matters related to caste census with senior leaders M Veerappa Molly, Abhishek Manu Singhvi and Salman Khurshid being part of the panel.

Senior leaders Mohan Prakash, R P N Singh, P L Punia and Kuldeep Bishnoi are the remaining members of the panel, a party statement said. Molly will be its convenor.

The Congress, during the Monsoon session of Parliament, had asked the government why it was "quiet" and "running away" from a caste-based census.

Asserting that there is a demand for a caste-based census from all quarters, Singhvi had said in Rajya Sabha the exercise is needed because the quota for backward classes has exceeded the determined limits in many states.

**NIA files chargesheet against Sachin Waze, Pradeep Sharma, eight others**

**Mumbai:** The National Investigation Agency on Friday filed a charge sheet against ten persons including former police officers Sachin Waze and Pradeep Sharma in the case of SUV with explosives found near Industrialist Mukesh Ambani's house and the murder of businessman Mansukh Hiran.

Besides Waze and Sharma, other accused named in the over 9,000-page charge sheet are Vinayak Shinde, Naresh Gor, Riyazuddin Kazi, Sunil Mane, Anand Jadhav, Satish Motkuri, Manish Soni and Santosh Shelar. Shinde had been suspended from the police force in a different case while Kazi and Mane were serving police officers when they were arrested. All the accused are now in judicial custody.

The accused have been charged under IPC sections for murder, criminal conspiracy, kidnapping and 'negligent conduct with respect to explosive substances' as well as provisions of the Unlawful Activities (Prevention) Act, Explosive Substances Act and Arms Act, the NIA said in a release.

The charge sheet cites 200 witnesses, a prosecution law-

yer said. The NIA, after it took over the case, clubbed three First Information Reports (FIRs) registered by Maharashtra Police, the release said.

The first FIR was registered at Gamdevi police station after an SUV with gelatin sticks and a threat letter was found on Carmichael Road in south Mumbai near Ambani's multi-storey house 'Antilia' in February this year. The second FIR was registered at Vikhroli police station about alleged theft of the same SUV - a Mahindra Scorpio - from the possession of Thane businessman Mansukh Hiran. The third


**India-Russia ties have stood test of time**

**New Delhi:** Prime Minister Narendra Modi on Friday said the India-Russia friendship has stood the test of time and asserted that the two countries together can help bring stability to the global energy market.

In his virtual address at the plenary session of the Eastern Economic Forum (EEF) being held in the Russian city of Vladivostok, Modi noted the "robust" cooperation between the two countries during the COVID-19 pandemic, including in the vaccination programme.

Lauding President Vladimir Putin's vision for the development of the Russian Far East, he said India will be a reliable partner for Russia in realising the vision.

Noting that India has a talented and dedicated workforce while the Far East is rich in resources, the prime minister said there is tremendous scope for Indian talent to contribute

to the development of the Russian Far East.

He recalled his 2019 visit to Vladivostok to attend the forum and the then announcement of India's commitment to an "Act Far East policy".

The policy is an important part of India's "special and privileged strategic partner-

ship" with Russia, Modi said.

"President Putin, I remember our detailed conversation during the boat ride from Vladivostok to Zvezda during my visit in 2019. You had shown me the modern ship-building facility at Zvezda and had expressed the hope that India would participate in this great enterprise. Today I am delighted that one of India's biggest shipyards, Mazagon Docks Limited, will partner with Zvezda for the construction of some of the most important commercial ships in the world," he said.
