OPENED 100 COMPANY OWNED COMPANY OPERATED (COCO) STORES OF DAVAINDIA BY DAVAINDIA HEALTH MART LIMITED, WHOLLY OWNED SUBSIDIARY OF THE COMPANY

SURAT, March 13, 2023: Zota Health Care Ltd (NSE: Zota): M/s Davaindia Health Mart Limited, the wholly-owned subsidiary of the Company (herein after “WOS”) has opened 100th Company Owned Company Operated (COCO) store of Davaindia. Davaindia is an eternal initiative of Zota Health Care Limited which revolutionized healthcare space in India by providing high quality generic medicines at a very low cost as compared to branded counter parts. In COCO store, WOS offering ~1700+ SKUs which includes Generic Medicines, Ayurvedic, Wellness, Nutraceutical and OTC products and around 95% of which are private labeled. By the blend of COCO and FOFO stores we have store network of 626 stores and till date saved Rs. 542.24 crores of citizen of India.”*
