**Note 1:** During the quarter under review, the Company's fixed deposits matured, and the proceeds were credited to its cash credit account. The proceeds received from conversion of warrants to equity shares were also transferred to the Company's cash credit account. For operational ease, the funds were subsequently transferred to various current accounts of the Company. As at the end of the reported quarter, the entire amount had been fully utilized from the aforementioned accounts.

**Note 2:** Out of the issue proceeds of Rs 179.07 crore, the Company has received issue proceeds of Rs 96.24 crores till the quarter ended March 31, 2025. Out of the received proceeds, Rs 90.24 crore is utilized till the reported quarter and unutilized amount of Rs 6.00 crore is parked in FDs. The balance amount Rs 82.84 crore is expected to be received by the warrant holders at the time of exercising the conversion rights, on or before the expiry of 18 (eighteen) months from the date of allotment of the Warrants i.e., February 13, 2026, as per the Notice to Shareholders dated July 13, 2024.

**Note 3:** Prior to the receipt of Rs 11.89 crore from the holders who exercised their rights for conversion of warrants into Equity Shares under the preferential issue and maturity of Fixed Deposits of Rs 9.00 crore, during the reported quarter, the Company had incurred expenses of Rs. 4.26 crore for the expansion of Davaindia project and the same has been financed through Cash Credit facilities from the ICICI Bank, the said expenses of Rs. 4.26 have been reimbursed from the issue proceeds of Preferential Issue.
